

**H. Dean and Susan Regis Gibson Research Award  
For Undergraduate and Graduate Students  
Deadline: February 28, 2020**

H. Dean and Susan Regis Gibson have generously given money to the University to help one or two outstanding graduate or undergraduate students with particular attention but not limited to female students to conduct brain imaging research in the Center for Cognitive and Behavioral Brain Imaging (see description below in General Guidelines).

**GENERAL GUIDELINES**

The H. Dean and Susan Regis Gibson Research Award is given on the basis of scholastic achievement, completed and/or intended research achievement, and the successful completion of a research proposal for conducting brain imaging research in the Center for Cognitive and Behavioral Brain Imaging. Funds from the award will be used to cover scanning time to allow the recipient to conduct their fMRI research, as outlined in the application proposal, in the CCBBI. The award maximum is \$3000 per recipient.

**CONDITIONS OF ELIGIBILITY**

To be considered for this research award, a student must:

1. Be a current graduate or undergraduate student at OSU.
2. Have a cumulative grade point average of 3.5 or higher.
3. Have completed, or will complete, an undergraduate or graduate level course on Magnetic Resonance Imaging.
4. Be enrolled full time in any semester you receive funds.

  - g. Analyses to be performed
  - h. Projected start and completion dates
  - i. Faculty advisor
  - j. Budget and budget justification
